- Must complete CDCRC Financial Literacy Program for certification
- This is a WPCU loan: Client can not have <u>any</u> financial loss to the credit union (ie: charge-offs or current bankruptcy) Bankruptcy must be discharged
- Cars must be purchased at Dayton—Xenia Auto Parts

- Automobiles purchased "As Is": See "This vehicle sold without warranty clause"
- Purchase Price between \$1,000-\$5,000
- Purchase Price determined on client's ability to purchase and to handle a loan payment, office of CDCRC will do budget
- May have to provide \$100 down payment (per discretion of WPCU)
